1. Roll Call and determination of Quorum

Roll call was made and Quorum was declared as adequate to proceed with the 2016 General Assembly of the JJAU.

2. Nomination of the Chairman and the Convener for the 2016 General Assembly

The members present unanimously nominated **Mr. Fahad Ali Al Shamsi**, Secretary General of JJAU as the Chairman of the 2016 JJAU General Assembly.

3. Welcome speech and the 2014- 15 Annual Report of the Hon. Secretary General

Mr. Fahad Ali Al Shamsi welcomed the members present and expressed his sincere appreciation **His Highness Sheikh Mohamed bin Zayed Al Nahyan, Crown Prince of Abu Dhabi and Deputy Supreme Commander of the UAE Armed Forces**, for his patronage, valued support & guidance for Ju Jitsu across Asia and requested Dr. Jaffer Al Muthafer, OCA Representative to commence the proceedings of the GA.

4. Report on International and Asia activities by the OCA Representative

Mr. Fahad Ali Al Shamsi, expressed his sincere gratitude to **H.E. Sheikh Ahamd Al Sabah, President of the Olympic Council of Asia** for his valued support for Ju-Jitsu in Asia and informed the Members that Ju- Jitsu is now a fully recognized OCA sports discipline and has been included in the 2018 Asian Summer Games at Jakarta, Indonesia, in the 2017 Asian Indoor & Martial Arts Games at Ashgabat, Turkmenistan and in the 2016 Asian Beach Games at Da Nang, Vietnam.

Dr. Jaffer AL Muthafer added that JJAU Regional Ju-Jitsu Championships have been conducted in all the five OCA designated regions of Asia and that the East Asia & South East Asia Regional Ju-Jitsu Championships will be held during the beginning of June 2016 in Vietnam and the JJAU Asian Beach Games will be held at Sri Lanka in July 2016.

Dr. Jaffer concluded his report by informing the members present that due to continued support of **His Excellency, Sheikh Ahamad Al Sabah, President of the ANOC**, and the dedicated efforts of the JJAU Board and the JJIF Presidency, Ju-Jitsu is now the **ONLY** Non-Olympic sport to have been admitted into the ANOC & IOC World Beach Games event In **San Diego USA**.
